### CHILD PROTECTION & SAFEGUARDING

Midleton RFC is affiliated to the IRFU, who fully support the Irish Sports Council's "Best Practice Guidelines" with regard to the Welfare & Protection of children in Sport. Midleton RFC has adopted the Child Welfare Policy as produced by the I.R.F.U. All coaches are required to undergo Garda vetting and also sign the IRFU's Declaration for Intent. ### PLAYER INSURANCE AT MIDLETON RFC

Midleton RFC is covered by the IRFU Compulsory Group Personal Accident Scheme for Clubs. This insurance only provides cover for the severest of injuries – loss of limb, loss of eye etc. Most schools offer 24/7 insurance through Alliance Insurance. By opting for 24/7 coverage rather than just in-school cover your child will be better insured. The offer normally closes at the end of October each year. Please contact your school for more details.
